Global Environmental Justice GEOG 435 (3 credits)(Fall 2023, Spring 2024)

This advanced course brings geographical perspectives on place, space, scale, and environmental change to the study of environmental justice. In lectures, texts, and research projects, students examine environmental concerns as they intersect with racial, economic and political differences. Topics include environmental policy processes, environmental justice movements, environmental health risks, conservation, urban environments, and the role of science in environmental politics and justice.

TEACHING (CORNELL UNIVERSITY, 2007-2023)

Environmental Justice and Policy

NTRES 4750/5750, DSOC 4750/5750, PADM 5172 (3 credits)(Spring 2022)

Co-instructed with Prof. Brenner

Course Description: Environmental justice is defined as the fair treatment and meaningful involvement of all people regardless of race, color, national origin, or income, with respect to the development, implementation and enforcement of environmental laws, regulations, and policies (USEPA, 2017). This hands-on course addresses key topics and themes in environmental justice. This course investigates the disproportionate impacts of climate change and related adaptation and mitigation efforts on vulnerable groups, especially communities of color and indigenous communities. In addition, this course looks at policy drivers and levers that may carve opportunities for change for the future.

Toxic Inequality: Environmental Justice in America

UNILWYL 1450 (1 credit)(Spring 2020, Spring 2021, Spring 2022)

Sole instructor Spring 2021; Co-instructed with Prof. Jamila Michener, Spring 2020 and Spring 2022

Course Description: This course explores social justice in the environmental context and will engage students in the theory and practice of environmental justice with a particular focus on inequality. Students should have a strong interest in learning about the history and challenges of environmentally overburdened communities — often communities of color and low-income communities—while also exploring strategies for addressing inequalities as they relate to the environment. Students will learn and practice critical reflection as an essential component of this course and we will employ visual, oral, and narrative forms of reflection to appeal to a variety of learning styles.

Global Sustainability: Community-Based Research Methods in Southeast Asia

NTRES 4000 (3 credits with required discussion section for GCS Borneo students; 2 credits for all others)

Pre-departure course (Fall 2013, Fall 2014, Fall 2015, Fall 2016, Fall 2017, Fall 2018, Fall 2019)

Course Description: This course provides an overview of methodology and methods in Community-Based Participatory Research (CBPR), including methodological considerations in building community partnerships and planning research and analyzing sustainability and resilience. The course will also cover qualitative research methods, such as narrative interviews, participant observation, ethnographic field notes, focus groups, and story circles. Course materials and case studies will emphasize the cultural and ethical considerations of working in developing countries, especially those in Southeast Asia, including issues associated with university-community partnerships and working with the University's Institutional Review Board.

In keeping with the philosophical underpinning of CPBR, class participation is expected, valued, and an essential part of the learning process. Learning will be structured through discussions of readings, listening to and engaging in dialogue, critical analysis of experiences and CBPR international case studies, and through your own participatory case study experiences. Students will be expected to complete assigned readings before the class in which they are listed and come prepared to discuss how the theory relates to CBPR practice and to students' own experiences in their respective fields. If you do not regularly and intensively engage with the course readings, you will get far less from this course.

We will approach each community-based research method from a variety of perspectives: learning about the method itself, considering examples of how it has been applied by other researchers and engaging in discussion and group work about the benefits and challenges and cultural implications of particular methods. Assignments will entail understanding, using, and applying each method. In this class, students will think critically about the

research process—how and why we use and combine research methods, how we design and conduct our data collection, what we assume explicitly and implicitly, and the ethical dilemmas and particular challenges raised by community-based and fieldwork-oriented studies. The course also examines university-community partnerships in research, particularly as it relates to post-colonial global citizenship and issues of sustainability in Southeast Asia. For a two-credit course, the expectation is 4 hours per week of outside study per week. The course readings and assignments are commensurate with that expectation. The course is required for students selected to participate in the Global Citizenship and Sustainability (GCS) program, which conducts a community-based research project in Southeast Asia.

**Global Citizenship and Sustainability: Service-Learning Borneo
NTRES 4001(1 credit Winter Session Field Course) (2013-present)**

Co-instructed with Amy Kuo Somchanhmavong

Course Description: The objective of this course is to help students learn about global sustainable development in a localized context involving isolated and remote indigenous communities living in tropical rain-forested areas that are of global ecological significance and which are regarded as highly vulnerable to the impacts of climate change. The community-based learning experience will be centered on the cultural and socio-economic sustainability and resilience of the participating communities. Community resilience is regarded here as “the capability to anticipate risk, limit impact, and bounce back rapidly through survival, adaptability, evolution, and growth in the face of turbulent change” (Community and Regional Resilience Institute-CARRI). It focuses on “the existence, development, and engagement of community resources by community members to thrive in an environment characterized by change uncertainty, unpredictability, and surprise.” The participating communities face several threats to their stability and to their economic and cultural survival but at the same time, they are able to harness significant assets to assist them in their development endeavors.

Students will be exposed to the multiple facets and perspectives of sustainable community development for indigenous minority groups with an emphasis on resiliency issues. Students will be able to interact with members of Long Lamai, Machan, and Bawang Assan villagers and researchers. Sustainable community development includes decision-making about livelihood options, which is intertwined with issues of social justice, cultural survival, power imbalances, and economic development. Students will be challenged by applying theoretical frameworks on global citizenship to relevant questions of ethics, power, democracy, diversity, culture and environment. These theories will be applied to the social dimensions of sustainable development, community, and cultural resilience in Malaysia. Teamwork, leadership and cross-cultural competency skills will be built upon through the research, UNIMAS, UCTS and Cornell students working together. At Cornell, the program is being offered by the Department of Natural Resources and the Public Service Center, at UNIMAS is offered by the Institute of Social Informatics and Technological Innovations (ISITI), and University College of Technology Sarawak.

This in-country field program provides students with a hands-on introductory experience in conducting community-based research. In addition, students will have exposure to the higher education system in Malaysia, its philosophy and approach toward community-based research and the opportunity to work and learn together with UNIMAS, and UCTS students regarding sustainable development and community and cultural resilience for indigenous communities.

**Community-Based Engagement and Analysis
NTRES 4002 (2 credits) (2013-present)**

Post-departure course

Course Description: The objective of the Global Citizenship and Sustainability (GCS) program is to help students learn about global sustainable development in a localized context involving isolated and remote indigenous communities living in tropical rain-forested areas that are of global ecological significance and which are regarded as highly vulnerable to the impacts of climate change. This is the post-departure course for

students that spend January in Borneo working with indigenous communities on community-based research. This course is focused on post-departure reflection, community-based engagement, and analysis.

Agents of Change: Community Organizing for the Public Good
NTRES 4820, 3 credits (Spring 2015, Spring 2016, Spring 2017, Spring 2018, Spring 2019)

Co-instructed with Prof. Peters and Prof. Levitt

Course Description: This course is aimed at engaging undergraduates from across the university in the study of what it means and involves to be an effective and ethical change agent in a democratic society. The course includes readings from academic literatures in theater, political theory, educational philosophy, international and community development, adult education, history, American studies, planning, and social movements. In addition, students complete writing assignments, engage in class discussions, listen to guest lectures, observe films and actively participate in performance and service-learning projects. Through the use of democratic, critical and multicultural pedagogies, the course engages students in a variety of activities aimed at developing their knowledge and skills in active listening and dialogue across diverse perspectives, and in relationship building with their peers, the instructors, and community partners. Course activities are process-oriented, drawing from theories of transformational and experiential learning that assist students in developing their abilities as self-directed, autonomous and socially responsible learners. Students are required to co-facilitate class sessions with the instructors and share the responsibility for selecting appropriate learning objectives, content, process, format and activities. They work in groups to identify and collaborate with community partners to plan, design, implement and evaluate a service-learning project.

Cook Conversations: Bridging Self, Community, and World
UNILWYL 1404 (1-credit *Learning where you live* course) (2016-2021)

Course Description: This interdisciplinary course serves as a pathway for engagement in the Alice Cook House community. One of the primary purposes of the class is to give students an introduction and exposure to the varied opportunities for engagement with guest speakers from Cornell, Ithaca, and global communities and also across social, environmental, and natural sciences, engineering, arts, and humanities. Through the course, we provide spaces (both physical and digital) for students to engage in informal discussions with Cornell faculty, other invited speakers, and with each other. The goal is to provide a platform for critical thinking and reflection within and beyond the boundaries of one's own discipline(s). Specifically, the course focuses on participating in the weekly speaker series and related events, course-based discussion and engagement, and reflection. Students also have the opportunity to recommend speakers for the series, in collaboration with Cook House faculty and staff. Students will interact with peers, faculty, guest speakers, and Cook House community members who will provide first-hand perspectives on their work. Students use reflection guidelines to share their reactions to the speakers via posting to a Blackboard discussion. In the course, students explore and learn about the breadth of disciplines at Cornell and beyond and how that relates to their own academic, personal, and professional experience. The course is targeted at residents of Alice Cook House (including the Language House) on West Campus, but is open to anyone at Cornell University.

Where do we go from here?
ART 2999 (1-credit *Learning where You Live*) (2018-2019)

Co-instructed with Prof. Gaskins

Course Description: The course centers on *The Origin of Others*, the latest book by legendary Nobel and Pulitzer Prize winner (and Cornell '55 graduate) Toni Morrison. This course is a learning where you live course designed for the Cornell residential communities on North and West Campus, bringing 1st year and upper level students together to learn. Students will engage with non-fiction, texts, documentary films, videos, and visual art by scholars, filmmakers, and visual artists of color to understand the intersections of race, class, and race-based structural inequalities at Cornell, in the country, and the world. The course considers the role of gender and nationality in the social architecture of structural inequality.

Introduction to Graduate Study in Natural Resources (NTRES 6000)(2012-2015)

Course Description: This class is designed to prepare incoming students for their graduate program in the Field of Natural Resources. The primary educational objective for this course is to gain the appropriate skills needed to meet the challenges and evolving needs of professionals charged with understanding, researching, and managing sustainable natural and human systems. The course includes discussions of the role of science in conservation, with a particular focus on how scientists pursue career paths toward effective participation in this realm. Discussions focus on the practices of scientists and institutions that provide a framework for scientific endeavors. The course is designed to allow new natural resources students to interact with one another on a weekly basis as well as with invited faculty, graduate students, and others. Topics will include writing and publishing, professional presentations, reading and critiquing literature, and navigating academia successfully (forming graduate committees and preparing for A-Exams, time management). This discussion-focused class is supported by readings.

TEACHING (PURDUE UNIVERSITY, 2001-2007)

At Purdue University (2001-2007), taught three courses a year, two undergraduate courses (FNR 365 and FNR 375) and one graduate course (FNR 575).

- **Natural Resource Policy, Issues, and Administration (FNR 365) and Human Dimensions of Natural Resources (FNR 375)** are required courses for undergraduate majors in forestry, fisheries and aquatic sciences, natural resources, and wildlife.
- **FNR 575, Human Dimensions of Natural Resources**, is the department's core course for graduate students specializing in social science aspects of resource management and policymaking.
- Purdue University Teaching Highlights:
 - Created two new courses (Human Dimensions of Natural Resources-FNR 375 and Human Dimensions of Natural Resources Graduate Seminar FNR 598D) and significantly revised the teaching methods and course content of one course (Natural Resource Policy, Issues, and Administration-FNR 365).
 - Between 2001-2007, directly impacted 575 students enrolled in 3 courses and generated 1,725 credit hours.
 - Project Investigator or Co-Project Investigator on 4 teaching and learning grants totaling \$135,000.
 - Organized and led a weekly professional development seminar series for graduate students.
 - Created a new summer course (Summer 2007), titled Ecological Science and Engineering Field Study (FNR 598A) to expose graduate students to field research and theory in interdisciplinary environmental science.
